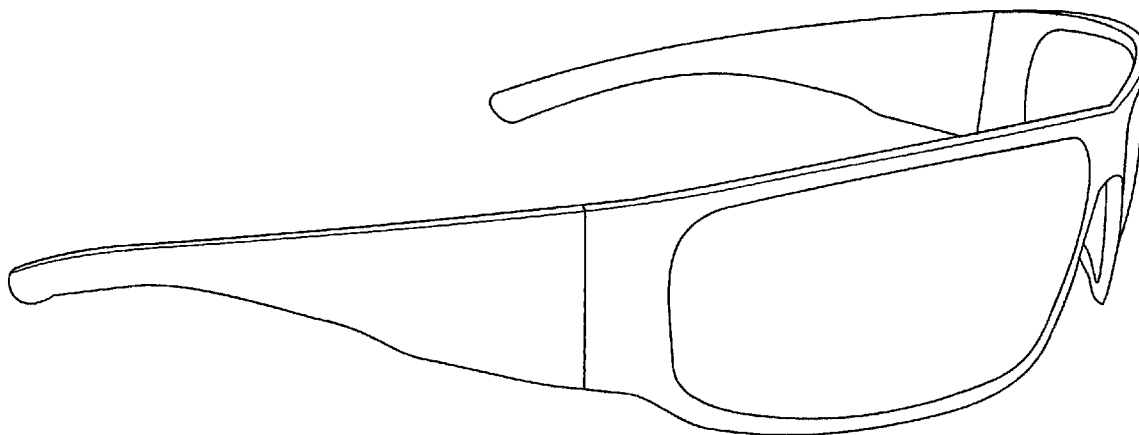
(57) **CLAIM**

What is claimed is the ornamental design for a sunglass frame, as shown and described.

DESCRIPTION

FIG. 1 is a top right perspective view of the sunglass frame with lenses installed therein;
 FIG. 2 is a bottom left perspective view of the sunglass frame with lenses installed therein;
 FIG. 3 is a front view of the sunglass frame;
 FIG. 4 is a back view of the sunglass frame;
 FIG. 5 is a top view of the sunglass frame;
 FIG. 6 is a bottom view of the sunglass frame;
 FIG. 7 is a right side view of the sunglass frame; and,
 FIG. 8 is a left side view of the sunglass frame.

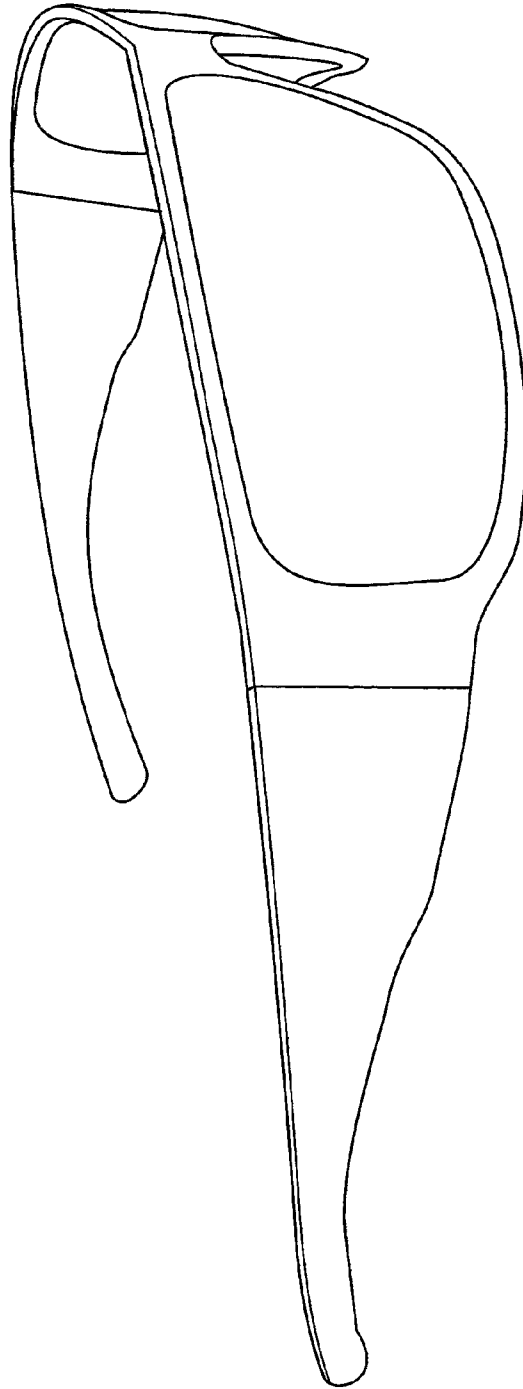

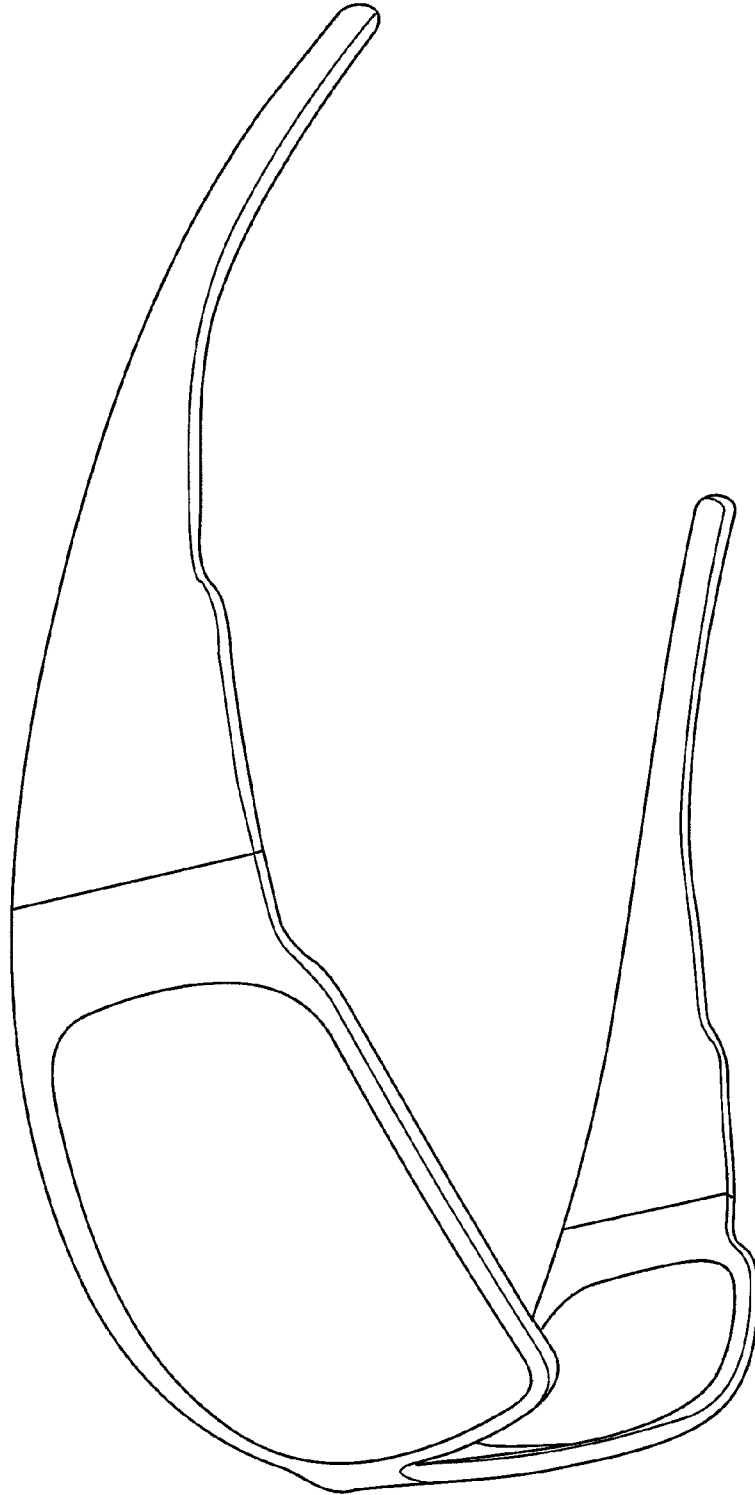

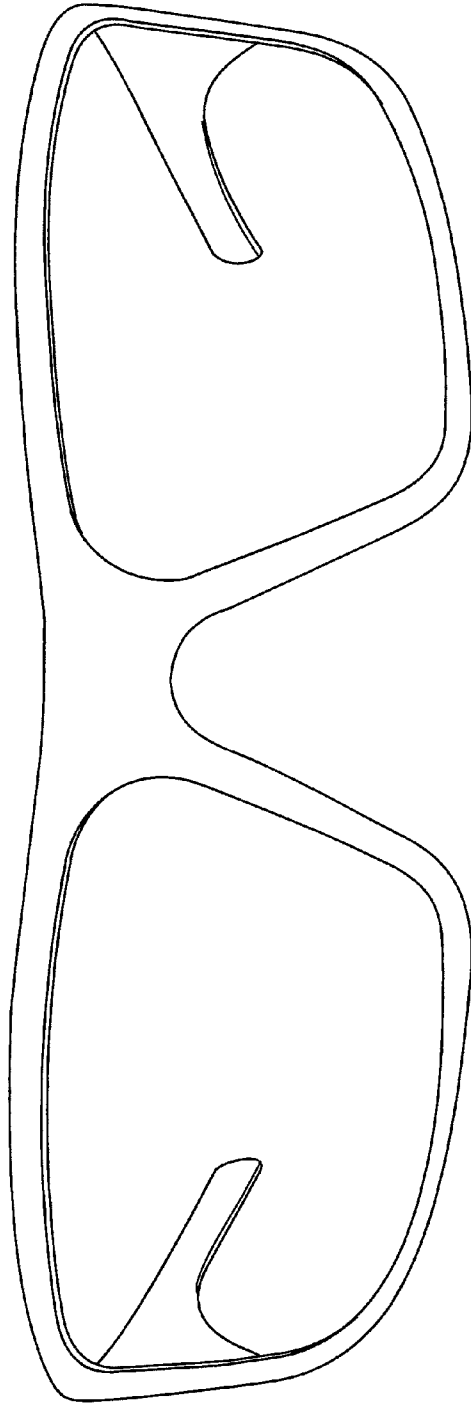

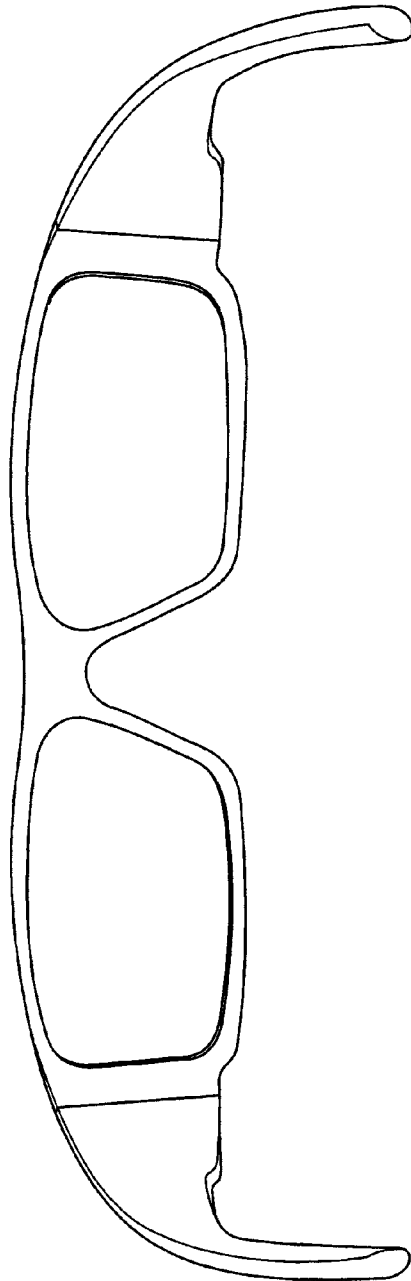

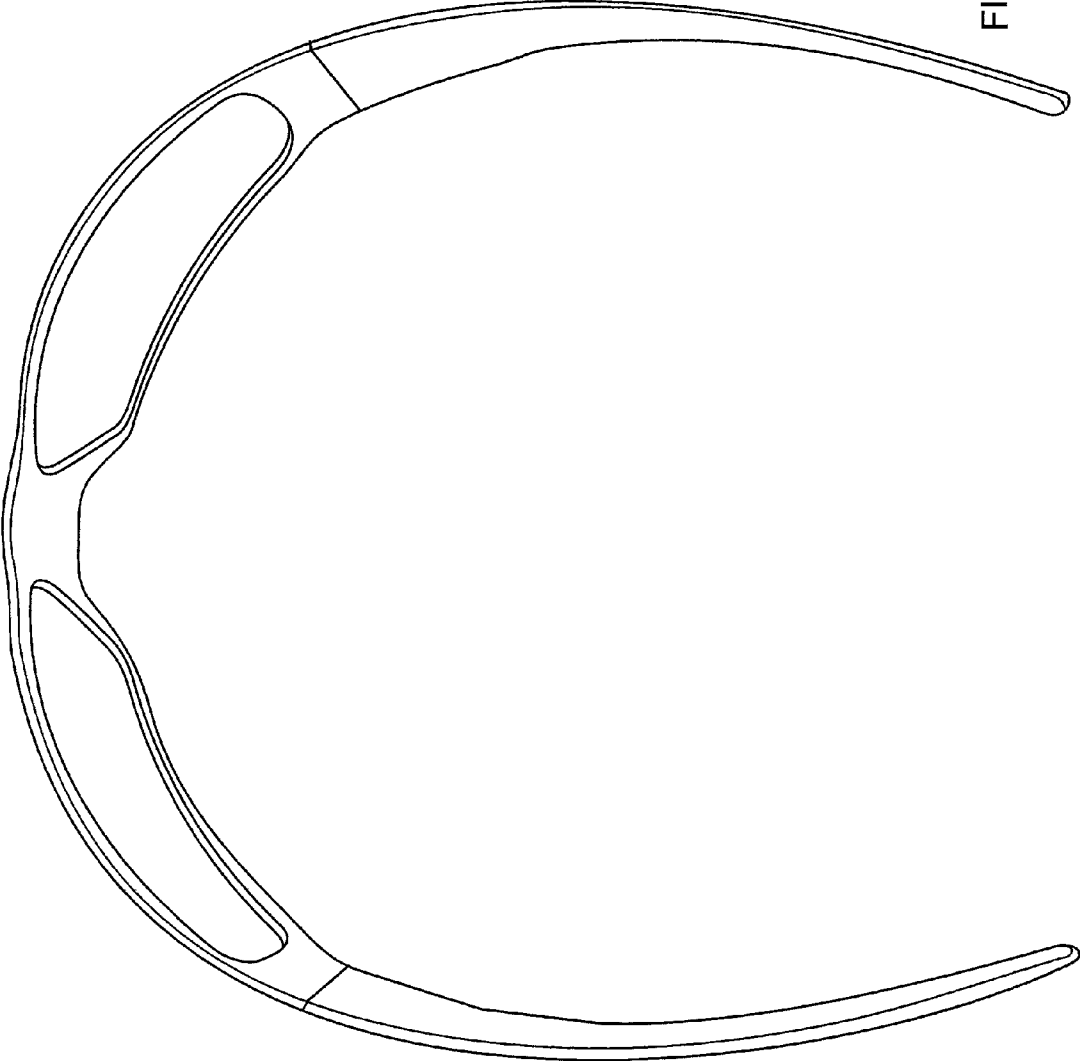

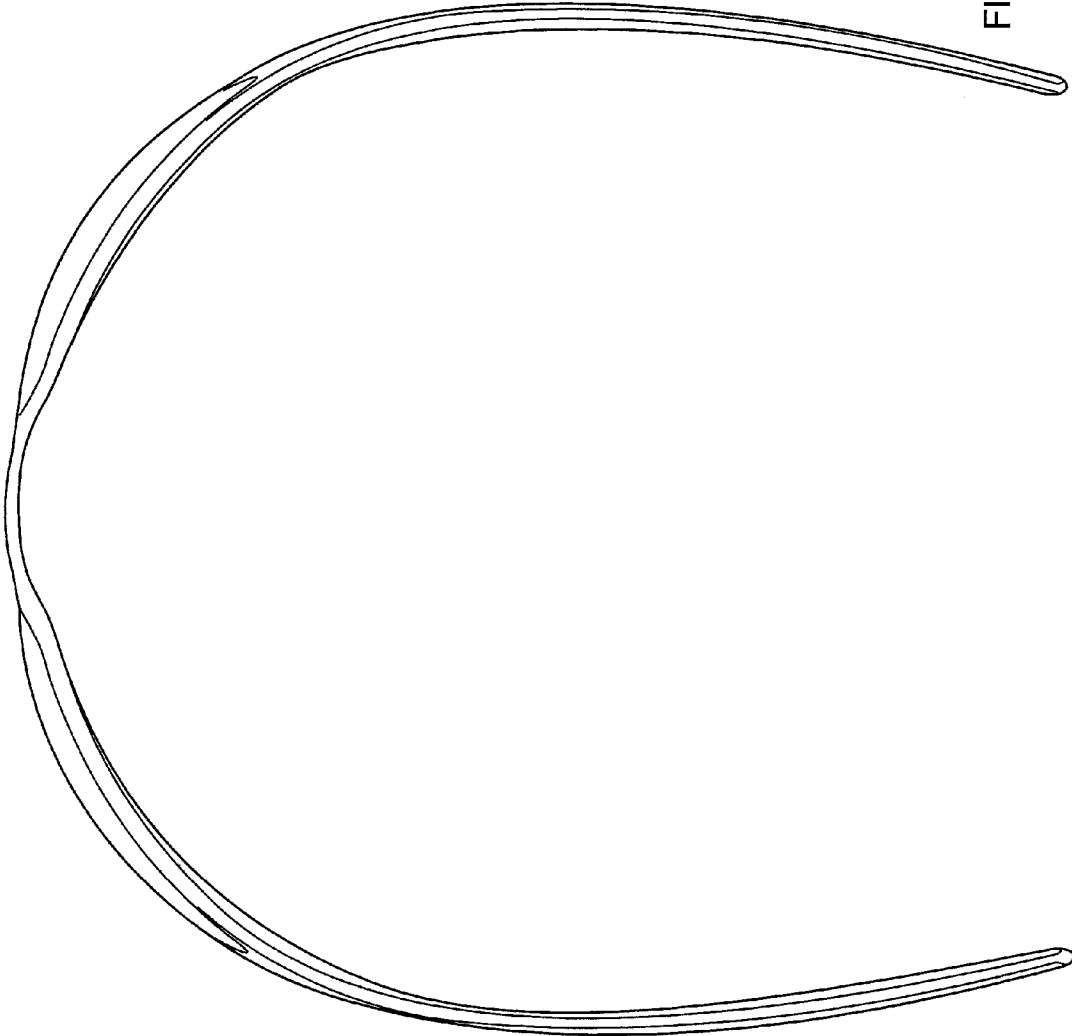

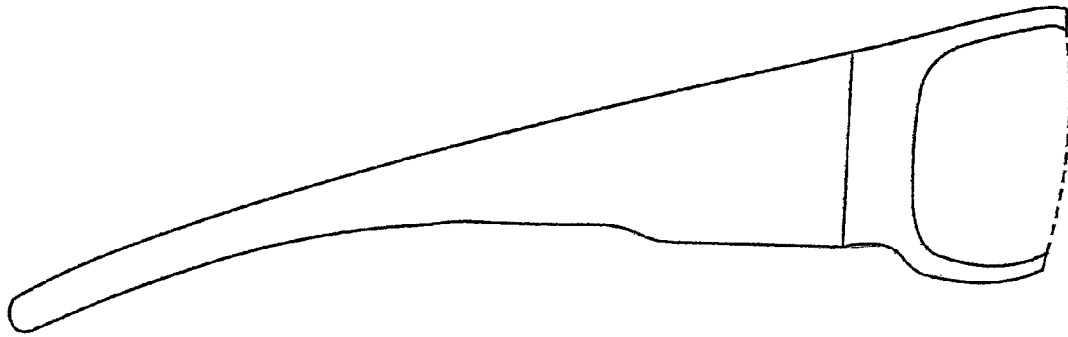

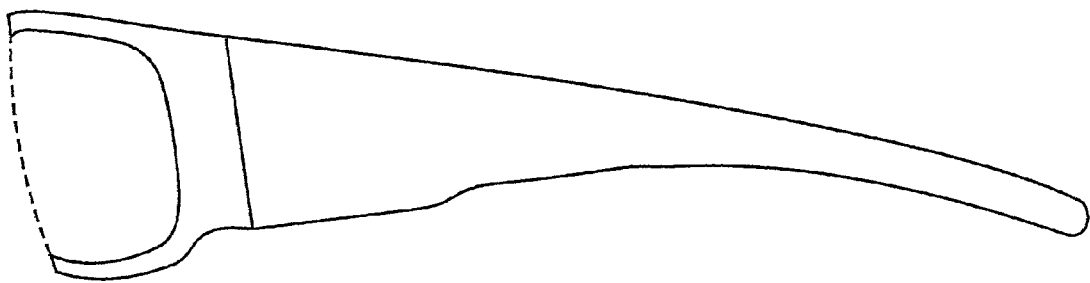
